## Payment Policies

### Registration Fee

- \$35 Registration fee is due at the time of registration.

### Recital Fee

- \$100 June End Year Recital Fee is due at the time of registration (does not apply to Baby Boogie and Adult/Teen classes).
- Remaining recital costume fees are due March 1<sup>st</sup> (if applicable)

### Monthly Fees

30 Minute class \$61

45 Minute class \$71

60 Minute class \$75

### Discounts

- A 15% discount is offered to a student's total tuition fees between September and June if fees are paid in full upon registration on or before August 31<sup>st</sup>, 2023.
- A 5% discount is offered to a student's total tuition fees for remaining months in the term if fees are paid in full upon registration on or before October 31<sup>st</sup>, 2023.

### Additional Payment Details

- **All fees paid are non-refundable including registration fees, costumes fees and tuition fees (including discounted payments in full).**
- Monthly Payments are due on or before the 1<sup>st</sup> of each month.
- Fees are the same for each month (September to June) even though some months have more classes than others.
- Payment must be made by a monthly e-transfer on or before the 1<sup>st</sup> of each month or in full at the time of registration to [info@leapforwardlangford.com](mailto:info@leapforwardlangford.com) using "what is the students first name?" or "what is the students first and last name?" as the security question.
- \$5.00 per day late payment fee is applied to all late payments.
- Fees owed after a student is no longer taking classes will be sent to our collection agency, Fees that are owed after a child has been withdrawn, with or without a calendar month of notice, will be sent to our collection agency, *In-House Receivable Services Ltd.* At this time, the account will be passed over in full to IRS and fees will be due to IRS. Once IRS has been handed the account, Leap forward Dance School would no longer be involved with the account.
